# **Scope**

This policy applies to all students at Downing College.

### **Policy**

The College's core values encompass freedom of thought and expression, and freedom from discrimination. The College is committed to maintaining a learning, living and working environment in which the rights and dignity of all members of the community are respected including all those who visit or interact with the College. The College therefore expects all members of its community to treat everyone with courtesy and consideration. Each person has the right to expect appropriate behaviour from others and has a corresponding responsibility to behave appropriately towards others.

To work and study effectively students need a climate of equal opportunity in which they are valued for their contribution, irrespective of their sex, gender identity (including reassignment), marital, parental or partnership status, race, ethnic or national origin, colour, disability, sexuality, religion or belief, or age. The College will not tolerate the harassment or bullying of any member of its community by another. Furthermore, any activity that contravenes these principles of inclusivity – whether intentionally or not – is damaging to our community and will be subject to the scrutiny of the College.
